[Note: Captain Joseph Fuller 1727-1807, died intestate (without a Will) and below are his Probate Court Records (transcribed) which in the most part corroborate the information in the Newton vital records and history books as follows:

Timothy Jackson was appointed Administrator of the estate. We assume the only son, Asa Fuller, was either unable or had moved to Vermont (as is reported in some history books of Newton) at the time of his father's death. He was not appointed administrator, as was the custom of the day and is only mentioned in the Probate Records as receiving a payment from the estate of \$130.50 on a note plus interest.

KNOW all Men by these Presents That we, *Timothy Jackson, Esq. m[ain] principal; & Joshua Park; yeoman & Ebenezer White, yeoman; as Sureties; allof Newton in the County of Middlesex & Commonwealth of Massachusetts.* [crossed out] within the Commonwealth of Massachusetts, are holden and stand firmly bound and obliged unto *James Prescott* Esq[uie]r Judge of the Probate of Wills, and granting Administrations within the County of *Middlesex* in the full Sum of *Thirty Thousand* Dollars in lawful money of said Commonwealth, to be paid unto the said *James Prescott* Esq. his Successors in the said office, or assigns; to the true payment whereof, we do bind ourselves and each of us, our, and each of our heirs, executors, and administrators, jointly and severally for the whole and in the whole firmly by these Presents. Sealed with our seals. Dated the *Sixteenth* day of *March* in the year of our Lord one thousand eight hundred and *seven*.

The CONDITION of this Present OBLIGATION is such, That if the above bounden *Timothy Jackson, who is this day appointed Administrator of the estate of Joseph Fuller late of said Newton, Gentleman Deceased,*

do make or cause to be made a true and perfect Inventory of all and singular the goods, chattels, rights and credits of the said deceased, which have or shall come to the hands, possession or knowledge of the said *Timothy Jackson* or into the hands and possession of any other person or persons for him and the same so made, do exhibit, or cause to be exhibited into the registry of the Court of Probate for the aforesaid county of Middlesex at or before the *sixteenth* day of June next ensuing; and the same goods, chattels, rights and credits, and all other the goods, chattels, rights and credits of the said deceased, at the time of his death, which at any time after shall come to the hands and possession of the said *Timothy Jackson* or into the hands and possession of any other person or persons for him do well and truly administer according to Law; and further, do make, or cause to be made a just and true account of his said administration upon

oath, at or before the *sixteenth* day of March which will be in the year of our Lord, one thousand *eight Hundred & eight*.

And all the rest and residue of the said goods, chattels, rights and credits which shall be found remaining upon the said administrator's Account, (the same being first examined and allowed of by the Judge or Judges, for the time being, of Probate of Wills and granting administrations within the County of Middlesex aforesaid) and shall deliver and pay unto such person or persons respectively, as the said Judge or Judges by his or their decree or Sentence pursuant to law shall limit and appoint:

And if it shall hereafter appear that any last will and testament was made by the said deceased, and the executor or executors therein named do exhibit the same into the court of Probate for the said county of Middlesex making request to have it allowed and approved accordingly; if the said *Timothy Jackson* within bounden being thereunto required, do render and deliver the said letter of administration (approbation of such testament being first had and made) into the said court: Then the before written Obligation to be void and of none effect, or else to abide and remain in full force and virtue.
